Surrogate Benefits Package

To reduce confusion, surrogates in every state and work situation receive the same base rate.

First-time Surrogate Base Compensation	\$50,000
Experienced Base Compensation	\$55,000

In addition to the above, surrogates will receive approximately \$7,000 in extra benefits detailed below, not including multiples fee.

Multiples Fee	\$5,000

In the event, you have a twins or multiples pregnancy the above is added to your base compensation monthly after 15 weeks gestation, or according to your individual GSA.

Medical and Psychological Screening	\$500
Monthly Allowance	\$250 commence with fetal heartbeat. 10 installments; total \$2,500.
Maternity Clothing-singleton	\$1,000
Maternity Clothing for Multiples	\$1,200
Housekeeping	\$2,000 commence with fetal heartbeat. 10 installments; total \$2,000
Lost Wages	Varies based on the surrogate's employment status and income earned. With proof of paystubs.
Spousal Lost Wages (10-days)	Varies based on the surrogate's spouse's employment status and income earned. Up to a max of 10-days. With proof of paystubs.
Childcare	\$15/hour not to exceed \$75/day per child
Commence Injectable Medication	\$500
Mock/Drop Cycle	\$500
Embryo Transfer Fee (each transfer)	\$1,000
Life Insurance	\$450,000 face value- benefit is shared with IPs as additional beneficiaries. Premium paid by IPs

In the event the surrogate will need to travel for her medical screening and embryo transfer we will arrange appropriate transportation, lodging and meals.

Travel Expense	TBD
Long distance travel by car	\$0.50/mile – first 50 miles

These procedures are situational-hopefully we never have to experience these events.

Miscarriage to no fault of the surrogate	\$500
Invasive Procedure/ per needle insertion (anything requiring anesthesia, amniocentesis, CVS, miscarriage with D&C)	\$1,500
Ectopic Pregnancy or Complication	\$1,500
Loss of Reproductive Organs	\$2,500 partial or \$5,000 full hysterectomy

There is no extra compensation for a normal delivery, these are situational as well. If a surrogate has previously had a c-section, or if she will need a c-section.

C-section	\$1,500
Breastmilk	\$250/week (plus pumping equipment, storage supplies, and shipping expenses)

In addition to the compensation mentioned above, the IPs will pay these expenses for the surrogate as well. These costs will be paid by the intended parent when a Gestational Surrogacy Agreement is signed with the IPs.
